Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the President of the United States is authorized, by and with the advice and consent of the Senate, to appoint as ensigns in the line of the Navy all of more, of future midshipmen who graduate from the Naval Academy in 1932, and at least 50 per centum of all graduates in subsequent years: Provided, amended. Provise. That the number of such officers of the provise as the total number of line officers otherwise authorized by law the setta numbers etc. of the total number of line officers otherwise authorized by law, be as extra numbers, etc. considered in excess of the number of officers in the grade of ensign as determined by any computation, and shall be excluded from any computation made for the purpose of determining the authorized number of line officers in any grade on the active list above the grade of lieutenant, junior grade, until the total number of line officers shall have been reduced below the number otherwise authorized by law.
